- A. **Next Meeting** Reminding you that our next regular meeting will be this Thursday, January 12, 7:00PM at the Richmond Firehouse. Agenda items include:
 - 1. **Budget preparation** President Dana Sullivan will appoint a financial committee to address the suggestions and discussion at the November meeting that M3R ought to develop an annual budget process and have the periodic financial reports be framed in terms reflecting the status of expenditures and revenues matched to the budget.

- D. *Topsham Library Date Scratched* -The tentative February 23 date for the Topsham Library has been scrubbed. We expect to return to Topsham next year.
- E. **Sellers and Buyers Beware Bad Actors in Connecticut -** Here is an item of potential concern to M3R members. NETTE Auctions, a/k/a New England Toy Train Exchange, 45 West Street, Danbury, CN, has been dissolved as an operating business and is no longer at its address. Newspaper reports indicate that a lawsuit was filed by the administrator of the estate of a deceased model railroader on November 8, 2016 for failure to pay almost \$35,000 in consignment sales. The Connecticut Attorney General's Office says

they have had several complaints and they are investigating also. Others named in the lawsuit are Donald and Naomi Karagianes who apparently were the owners of the defunct company.
